### The Bengalla CCC Newsletter...

The material in this issue of the Bengalla Mine Community Consultative Committee (Committee) newsletter has been selected by the CCC representatives.

The Committee is comprised of community representatives and representatives from Bengalla Mine including the General Manager. This newsletter aims to inform interested community members on matters discussed during CCC meetings.

## Bengalla Mine Rapid Antigen Testing Facility

The Bengalla 'RAT Pack' has been hard at work establishing and operating a Rapid Antigen Testing (RAT) Facility near the site entrance of Bengalla Mine.

Employees are currently selected for a daily RAT screen based on NSW Health Advice. Contractors attending Bengalla are tested daily.

To undertake a RAT at the Facility you turn left just after the site entrance and drive to the purpose built Facility where you can complete a drive-through test, or walk in to the Facility to complete the procedure. The nasal swab takes a few seconds with results of the RAT texted to the mobile phone 15 minutes later. If clear work is started.

Commencing the RAT last week we are currently completing around 300 tests per day to reduce the health and safety risks for our onsite workforce enabling continuity of operations and ongoing support for our suppliers and contractors.

Many thanks to the Bengalla family for ensuring that the Facility got off to a strong start last week and a special thanks to Mt. Arthur Coal and Mt Pleasant who provided advice regarding establishing and operating the RAT.

### **Other COVID Measures**

Bengalla Mining Company have been conducting wastewater SARS-COV –2 detection testing frequently, now twice weekly. This testing is in addition to our other precautions including wearing masks, social distancing, temperature testing when logging in, and regular cleaning.

We have also provided support to the local community through contributions to the Muswellbrook Chamber of Commerce and Industry's initiative of Care Packs. The Care Packs are distributed to affected local business owners and their families who are experiencing difficulty.

Workpac, a Bengalla contractor, has been able to assist with our RAT testing onsite through the provision of some of their workforce.

Bengalla continues to be focused on providing support to our suppliers and contractors and employees by continuing operations in this challenging environment.
